## **SPARK Membership Agreement**

*PLEASE READ THE FOLLOWING AGREEMENT CAREFULLY. BY SIGNING THIS APPLICATION YOU ARE ENTERING INTO A BINDING LEGAL CONTRACT.*

*I (We) will only breed Rottweilers who comply with the USRC standard for the Rottweiler. I (We) will only breed Rottweilers who are at least 2 years of age. I (We) will only breed Rottweilers who have been certified Free, HD +/-, HD A or HD B for hip dysplasia by OFA, or an FCI member kennel club or Rottweilers who have a valid USRC recognized Zip. When docking, I (We) will only dock tails on dogs less than 7 days old and will dock the entire litter.*

*As a Southeastern PA Rottweiler Klub (herein known as 'SPARK') member, I (We) fully understand that the SPARK is a hobby club made up of people interested in the Rottweiler breed. When participating in SPARK sanctioned events or utilizing the membership privileges extended to me (us) by SPARK, I (We) do not expect to receive any type of financial gain either personal or business related from the outcome of events or from the issuing of titles by judges or from the issuance of SPARK related paperwork and materials.*

*By the signing of this document I (We) agree to uphold the rules and by-laws of SPARK and the USRC at all times. I agree to conduct myself in a conscientious and sportsmanlike manner at any and all SPARK/USRC events. In consideration of and as inducement to the acceptance of my (our) application for membership in SPARK or the acceptance of my (our) event entries, I (We) hereby agree to release, discharge, and hold harmless SPARK, its officers, directors, members, employees, agents, ensigns, family members and event volunteers in advance from and against any and all liability, whether foreseeable or unforeseeable, arising out of or in any way connected with activities of SPARK, even though that liability may arise out of negligence or carelessness on the part of SPARK or any person or entity acting on or alleged to have been acting on their behalf. I (We) further understand that by their very nature, sporting activities involving dogs have a potentially increased risk of personal injury and property damage.*

*I (We) therefore agree to assume all the risks of injury to my person or property, whether known or unknown, that could arise out of my (our) participation in activities of SPARK. I (We) further agree that I (We) will not litigate or threaten to litigate against the SPARK organization, SPARK Officers or Directors, SPARK Members or their representatives, employees, agents, emblems, family members or event volunteers in any manner for any reason whatsoever and understand that such actions whether verbal, written or implied are grounds for immediate and permanent expulsion from SPARK.*

*I (We) agree that any cause of action, controversy or claim arising out of or related to the membership, entry, exhibition, judging or attendance at the event between SPARK and a SPARK Member or as to the construction, interpretation and effect of this agreement shall be settled by the United States Rottweiler Club dispute resolution procedures. However, as a precondition to utilizing the USRC dispute resolution procedures to settle disputes, all applicable SPARK bylaws, rules and regulations and procedures must first be followed as set forth in the SPARK bylaws, rules, regulations, published policies and guidelines.*

*I (We) understand that a condition of SPARK membership is maintaining membership within the United States Rottweiler Club. I (We) understand that if at any time during the course of my (our) SPARK membership, my (our) USRC membership should be cancelled, suspended, revoked or terminated for any reason whatsoever, including but not limited to non-payment of USRC dues, etc., that my (our) SPARK membership will also be automatically terminated.. I (We) understand that if my (our) USRC and/or SPARK membership is cancelled, suspended, revoked or terminated for any reason whatsoever, or if I(We) voluntarily resign from SPARK at any time for any reason whatsoever, that I (We) automatically forfeit any and all membership dues, fees or monies paid to SPARK.*

*I (We) understand that the signing of this membership application constitutes agreement to the SPARK Membership Regulations as a condition of becoming and remaining a member of the Southeastern PA Rottweiler Klub. I (We) understand that the terms of this membership agreement are upheld from renewal year to renewal year by the act of submitting yearly klub dues. I (We) understand that the terms of this Membership Agreement are subject to change at any time without notice. I (We) understand that violation of this membership agreement may result in the loss of SPARK privileges and could include expulsion from SPARK.*
